NOW THEREFORE, Recipient, on behalf of itself and its heirs, assigns and all other persons or entities claiming by, under or through Recipient, represents, covenants and agrees as follows:

1. Recipient accepts and voluntarily incurs all risks of any injuries, damages, or harm which arise during or result from any activities of or services provided by Camp Kum-Ba-Ya, Christian Church In Kentucky--West Area, and/or the Christian Church In Kentucky or its staff members, officers, agents or representatives, except only to the extent caused by the negligence or other fault of Camp Kum-Ba-Ya, Christian Church In Kentucky--West Area, and/or the Christian Church In Kentucky, The Trustees of Camp Kum-Ba-Ya, Christian Church In Kentucky--West Area, and/or the Christian Church In Kentucky, and/or its or staff members, officers, agents, representatives or insurers ("Released Parties").
2. Recipient waives, releases and forever discharges all claims against any of the Released Parties for any injuries, damages, losses or claims, whether known and unknown, which arise during or result from any activity of or services provided by any of the Released Parties under or in connection with Camp Kum-Ba-Ya, Christian Church In Kentucky--West Area, and/or the Christian Church In Kentucky, including but not limited to any such injury, damage, loss, or claim arising from any services provided as part of Camp Kum-Ba-Ya, Christian Church In Kentucky--West Area, and/or the Christian Church In Kentucky, except only to the extent caused by the negligence or other fault of any of the Released Parties.
3. Recipient agrees to indemnify and hold the Released Parties harmless from all losses, liabilities, damages, costs or expenses (including but not limited to reasonable attorneys' fees and other litigation costs and expenses) incurred by any of the Released Parties as a result of any claims or suits that (i) Recipient, (ii) anyone claiming by, under or through Recipient, or (iii) any third party, may bring against any of the Released Parties to recover any losses, liabilities, costs, damages, or expenses which arise during or result from the participation by, or services supplied by, any of the Released Parties, except only to the extent caused by the negligence or other fault of any of the Released Parties.
4. Recipient acknowledges having carefully read and reviewed this Waiver, Release and Hold Harmless Agreement, and Recipient represents that it fully understands and voluntarily executes the same.
